WIIT S.p.A.: operation of the Company's shares

Milan, 28 November 2017 - WIIT S.p.A. ("**WIIT**", "**Company**" or "**Issuer**") makes known that it has received notice from WIIT Fin S.r.l. (the Issuer's shareholder, a subsidiary of the CEO Alessandro Cozzi) and 4Fin S.r.l. (shareholder of the Issuer, a company controlled by the manager Riccardo Mazzanti) of the transfer from 4Fin S.r.l. to WIIT Fin S.r.l. of n. 3,500 WIIT shares, for a consideration of € 57.00 for each share (the "**WIIT Shares**"). These shares differ from the ordinary shares of the Issuer listed on AIM Italia as they do not grant the right to assign the c.d. remedy shares (as described in the Company's Admission Document available at www.wiit.it) and are distinguished by the different ISIN IT 0005256083 code.

WIIT Fin S.r.l. therefore holds 1.625.146 shares of the Company (ISIN IT 0005256083), corresponding to 63.33% of the share capital and 4Fin S.r.l. holds 76,535 shares of the Company (ISIN IT 0005256083), corresponding to 2.98% of the share capital.

The transfer of the WIIT Shares occurred after obtaining the consent of the Global Coordinator, Intermonte SIM SpA, and NOMAD, Advance SIM SpA, for the purposes of the lock-up agreement of 31 May 2017 signed in the process of admission to listing of the Company's shares on AIM Italia. It should be noted that WIIT Fin S.r.l. assumed in connection with the WIIT Shares the same lock-up commitments already made with reference to the other WIIT shares held by the same and that the lock-up commitments of 4Fin S.r.l. will remain unchanged with reference to the residual holding held in the Company. Lastly, the mechanism of c.d. remedy shares will not be affected by the transfer of WIIT Shares from 4Fin S.r.l. to WIIT Fin S.r.l.
